## Aquatic Weed Control: (Dean Long)

Received waiver from DEC for application of Clearcastfor water chestnut (treatment toward mid July). Treatment will take place at mouth of Kaydeross. Improved mapping this year (looking for Curley leaf pondweed). Milfoil map – low density on lake, little pond weed. Better reporting this year. Increased communication with the public through outreach. Questions arose of why we cant treat the entire lake. We cannot treat native weeds.

### Weed Harvesting: (Bob Hahn)

Lots of Richardson weeds near Kaydeross and Stony Point at Silver Beach. All equipment is up and running. Walter Supley MADE A MOTION to accept the Weed Harvesting Report, 2<sup>nd</sup> by Karl Hardcastle. MOTION CARRIED.

# Lake Stewardship: (Cristina Connolly)

Tom Carringi MADE A MOTION to add a 6<sup>th</sup> Lake Steward with all conditions same as the other 5, 2<sup>nd</sup> by Cristina Connolly, MOTION CARRIED. The stewards are stationed at the NYS boat launch and at the South Shore Marina. Lake Stewards are writing articles and submitting to Dean Long and Tracey Clothier. Upon approval they will be forwarded to Walter Supley to place website. Lake Stewards have also been going door to door with information and handouts. Mark (Lake Steward) has found a Chinese mystery snail. He has also noticed zebra mussels on a boat coming out of the water. Bob Hahn mentioned he has a large supply of the tri fold brochure as well as some maps. He will drop them off to Tom at Point Breeze Marina to hand out to the public.
