Spoke with Brad. Will create analysis for water chestnut report in September. Milfoil is very low. Earl weed grass is native weed. Grant with town of Malta will be wrapped up.

Lake Stewardship Report: (Cristina Connolly)

State park stewards finished at the boat launch on August 12. Three SLPID stewards are on until at least September 28. The following weekends are regattas.

Did another floating classroom with the town of Stillwater parks and rec department. Have one scheduled next summer for city of Saratoga springs.
